This letter refers to corrective actions taken by the Muskegon Gounty Wastewater Management System relative to deficiencies cited in your letter of November 27, 1990, regarding License No. 21-16814-01; Docket No. 030-11690;

 You failed to notify the NRC of your change of the Radiation Safety Officer and the main users of the licensed material (License Condition 11).

Due to a change in personnel, Condition 11 should now read: Licensed material shall be used by Brian Bates, Chemist, under the supervision of Donna J. Spytma boratory Supervisor. Material shall be set in accordance with manufacturer's guidelines.

 You failed to perform leak tr ts during the required six (6) month intervals (License Condition 13(A)(1).

> Leak tests were performed November 19, 1990, and results have been included. Due to a change in personnel, this test was overlooked for two six month periods. Future leak tests have been scheduled to be performed on specific dates and posted so that omission does not occur again.

 You failed to keep the radioactive material secured from unauthorized removal (IOCFR Part 20,207).

Because the Administration Building doors were locked at night, it was not thought to be necessary to lock the laboratory doors as well. Laboratory doors are now locked at night, weekends, and holidays when laboratory personnel are not in attendance (See attached memorandum).


