Gentlemen:

The purpose of this letter is to provide Wolf Creek Nuclear Operating Corporation's response to the Regulatory Effectiveness Review (RER) report transmitted by the Reference. The response addresses both Safeguards Inadequacies and Safeguards Program Concerns identified in the RER report.

A Safeguards Inadequacy is a significant deficiency in an essential element of the safeguards program warranting prompt correction. A Safeguards Program Concerns is a weakness in a nonessential element of the safeguards program or a weakness in an element that is partially mitigated by other factors, but warrants attention. Three Safeguards Program Concerns, sections 2.3.1, 2.3.2, and 2.5.1 of the Reference, and one Safeguards Inadequacy, section 2.4.1, were identified in the RER report.

The attachment contains Safeguards Information in accordance with 10 CFR 73.21 and therefore should be withheld from public disclosure. This letter, when separated from the attachment, does not contain Safeguards Information and should be handled as decontrolled.


