12. DESCRIPTION OF AMENDMENT/MODIFICATION

Pursuant to Clause No. 34 of the General Provisions entitled "Negotiated Overhead Rates," the following modification is made:

ARTICLE V - OVERHEAD/GENERAL AND ADMINISTRATIVE RATES, is amended to read as follows:

"A. The contractor shall be reimbursed for allowable indirect costs hereunder at the final overhead rate of 79.62% of direct labor costs for the period 9/26/80 - 4/30/81.

B. The contractor shall be reimbursed for allowable indirect costs hereunder at the final general and administrative rate of 38.14% of direct labor, Engineering labor overhead, travel and other direct costs for the period 9/26/80 - 4/30/81."

This modification also deobligates the unliquidated balance of \$12,650.26 remaining in the contract. As a result of this modification the total amount obligated by the contract is decreased from \$29,583.16 to \$16,932.90.
