OF KEY DOCUMENTS RELATED TO THE DEVELOPMENT AND

IMPLEMENTATION OF THE EPA HLW STANDARD

The staff of the Performance Assessment and Hydrology Branch (PAHB) has completed its collection and review of key documents related to the development and implementation of the Environmental Protection Agency (EPA) high-level waste (HLW) standard.

PAHB staff conducted a thorough review of staff files available within the branch and identified 111 documents fitting the description of "key document" as initially defined by the Commission Decision Tracking System (CDTS) Project Office. A keyword search of NUDOCS revealed no additional key documents. No Congressional testimony or Q's and A's were included in this review as they have not been made available from the Office of Congressional Affairs. From an initial field of over 350 documents related to the EPA standard, 111 documents were found to meet the CDTS criteria.

According to the Project Office, a "key document" is one that has reached the Commission's attention, is linked to one or more significant issues, and treats these issues in a substantive manner. Subsequent to the completion of this search, further guidance was received from the Project Office indicating that 111 documents for a single issue is too large a number for efficient operation of the CDTS. Consequently, PAHB staff have identified a subset of 30 key documents that contains only those documents which directly address topics relevant to the reconsideration of the EPA standard as prescribed under the Energy Policy Act of 1992. The contents of this subset are itemized in the attached listing. Hard copies of each document along with a cover sheet containing identifying information and linkages to other HLW issues will be provided to Ken Kalman for transmittal to the CDTS Program Office. In addition, the enclosed listing, along with a complete set of copies of the 30 cover sheets, will be provided for the Division's records.
