UCS/NYPIRG is continuing to review public docket files and organizational files for documents which we may use as described in the Staff's interrogatory. We anticipate using NRC Staff and licensee-generated documents regarding the compliance of Indian Point Units 2 and 3 with TMI Action Plan requirements, status of safety-related and safety-grade equipment with regard to environmental qualification, and the status of compliance with fire protection requirements.
