The purpose of this modification is to provide incremental funding in the amount of \$100,000.00. Therefore, the contract is modified as follows:

Under Subsection B.4 entitled "CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUNE 1988)," the first sentence of paragraph b. is deleted in its entirety and substituted with the following in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$675,000.00."
