The purpose of this modification is to provide a three month extension through March 31, 1991 to provide 800 service for the NUDOCS in the Ford Building. Accordingly, the contract is hereby modified as follows:

Under Section F, Deliveries and Performance, subsection F.1, Duration of Contract Period, is revised to read as follows:

"This contract shall commence on February 18, 1987 and end on March 31, 1991. The contractor shall provide 800 service commencing March 1, 1987 and ending on March 31, 1991."
