# TURKEY POINT UNITS 3 AND 4 OPERATIONAL SAFEGUARDS RESPONSE EVALUATION

#### Concern # 1: Current Response Strategy

A response station, manned with armed responders ready to interdict themselves between adversaries and target sets, will be added. The location of this station will reduce the timeline to interdiction.

### Concern # 2: Contingency Response Training

The annual security officer re-qualification has been amended to place more emphasis on those tasks which are not performed on a routine basis, particularly tactical response. The security gun range has recently undergone major modifications. The range now has a moving target system, Dualatron pop up/swing out target system, and simulated walls. This new arrangement will allow the trainers to configure the firing line to simulate several plant areas. In-plant drills will continue during low activity time frames in order to involve the entire security force.

#### Concern # 3: Deadly Force

The proper application of deadly force is addressed in annual training referencing applicable state statutes and NRC Information Notice 89-05. Field training will be enhanced by the use of the moving and Dualatron pop up/swing out target systems to challenge the officer to make on-the-spot decisions on the proper application of deadly force. The enhanced training will also put the officer in a stressful situation where an adversary is challenged and stopped. The officer must maintain target acquisition until the target moves or surrenders.

With proper training and drills, using various armed/unarmed adversaries, proper application of deadly force will be reinforced. There are no plans for training security officers in the use of non-lethal means for subduing unauthorized individuals.

## Concern # 4: Weapons Training

FPL's Security Force Weapons Training includes the following:

- The Annual Training Program has been modified to incorporate more site-specific tactical training.
- Incorporation of table top exercises in annual training.
- 3) Increased emphasis on management expectations with respect to participation by security officers on "open range" days at the security gun range.
- 4) Continued participation in the annual Homestead Police SWAT School, as available.
