TELECON WITH MR. E. N. WALZ

Mr. Walz returned my July 19 call to him concerning the issuance of License No. 22-13585-02G and Amendment 3 to License No. 22-13585-01 to Nite-Site, Incorporated, covering the general license distribution of self-luminous gun sights and the servicing of these gun sights.

The apparent mix up in dispatching of the licenses was explained to Mr. Walz and it was suggested that he determine what, if anything, was received by Nite-Site, Incorporated. It was explained to him that we still have the original of the Nite-Site -02G license, but do not have the licensee's file copy which may have been dispatched to Nite-Site along with the Amendment 3 to their -01 license.

It was further explained to Mr. Walz that since the -02G license was undated June 13, 1971, instead of July 13, 1971, we will have to issue a corrected copy of this license with the correct date of issuance. Therefore, Nite-Site will receive the incorrectly dated license along with the corrected copy.

Mr. Walz agreed to contact Nite-Site and call back in a day or two reporting the situation with respect to their receipt of the -02G license and/or the Amendment 3 to the -01 license.
