Gentlemen:

This letter refers to the special safety inspection conducted by Messrs. M. J. Kopp and G. M. Hausman of this office during January 7-11, 1991. During this inspection, we evaluated activities at the Quad Cities Nuclear Power Station, Units 1 and 2, authorized by NRC Operating Licenses No. DPR-29 and No. DPR-30. We discussed our inspection findings with Mr. R. A. Robey and others of your staff on January 31, 1991.

The purpose of this inspection was to review your actions about previously identified environmental qualification (EQ) concerns and to follow up unresolved items pertaining to Regulatory Guide (RG) 1.97.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, we selectively examined procedures and representative records, made observations, and conducted interviews with your personnel. During the inspection, two items identified in your environmental qualification files and LER 88-010 appeared to be in violation of NRC requirements. The inspection showed that actions had been taken to correct the identified violation and to prevent recurrence. Consequently, we have exercised our discretion as allowed under the NRC Enforcement Policy. Because we want to encourage prompt self-identification and correction of problems, the violation is not being cited because the criteria specified in 10 CFR Part 2, Appendix C, Section V.G. of the Enforcement Policy were satisfied. We did not identify any other violations of NRC requirements during the inspection.

In accordance with 10 CFR 2.790 of the Commission's regulations, we are sending a copy of this letter and the enclosed inspection report to the NRC Public Document Room.
