Gentlemen:

Thank you for your letter dated November 24, 1982, which was submitted in response to the item of noncompliance which we brought to your attention in Inspection Report No. 50-237/82-21; 50-249/82-22; 50-254/82-17; 50-265/82-19 forwarded by our letter dated October 26, 1982.

Your letter has been reviewed, and particular attention was given to your belief that the current non-compliance is not warranted, and should be withdrawn. Our position remains that this is considered an item of noncompliance. The NRC Region III inspection at EDS Nuclear Inc. that identified a virtually identical noncompliance to the one cited at Nutech Engineers was conducted in May 1982. In June 1982 you completed a review of your 1982 off-site vendor audit schedule to assure that appropriate vendors are being audited during the current program. In July 1982 you conducted an audit at Nutech which included a review of their internal QA audit program. Our inspection at Nutech identified certain fundamental deficiencies in their QA audit program which your audits conducted in 1980 and 1982 should have identified. In addition, your letter acknowledges you conducted no audits at Nutech during the period 1977-1979.

This letter also acknowledges our receipt of the EDS Interface Control Instructions and other IE Bulletin 79-14 control documents.

We will examine these matters during a followup inspection. Your cooperation with us is appreciated.
