The violation is of concern because it involved the deliberate falsification of Quality Verification personnel signatures by a maintenance foreman. While there was no safety impact on plant equipment, the NRC views with great concern violations which involve personal integrity issues. This is even more important when the individual is a supervisor. We understand that you did not consider this individual to be a formal supervisor and questioned why this violation did not meet the criteria for enforcement discretion. Title 10 of the Code of Federal Regulations Part 2. Appendix C. Section VII.B. does not permit the exercising of enforcement discretion for willful violations involving "licensee officials." This individual directly supervised and reviewed work performed on safety-related equipment by maintenance personnel.
