In accordance with 10 CFR 50.90, South Carolina Electric & Gas Company (SCE&G) hereby requests an amendment to the Virgil C. Summer Nuclear Station (VCSNS) Technical Specifications (TS). The proposed changes have been evaluated and determined to be non-significant and administrative in nature.

The purpose of this change is to permit equivalent testing methods to be performed on the diesel fuel oil purchased for the Emergency Diesel Generators, and to change the revision level of a Westinghouse WCAP that will be used in determining the VCSNS Core Operating Limits for future cycles.

SCE&G requests that the NRC review and approve this administrative TS change by September 30, 1994, in order to support preparations for Cycle 9.
