This refers to the Readiness Assessment Team Inspection (RATI) led by Mr. Larry E. Briggs of this office on February 4-8, 1991, at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. The results of the inspection are documented within the enclosed inspection report. At the conclusion of the inspection, Mr. Briggs and Mr. Curtis Cowgill of this office held an exit interview with you and members of your staff to present the preliminary results of this inspection.

The purpose of the inspection was to assess management systems used for oversight and control of activities in the areas of operations, maintenance and surveillance, and safety assessment and quality verification to assure protection of the health and safety of the public. The inspection consisted of interviews with plant staff and operations personnel, plant tours, observation of plant activities in the selected areas, and examinations of selected procedures, records, and documents.

Pending completion of required maintenance and restart preparations, the Team concluded overall licensee performance was at a level that should provide adequate assurance of safe facility operation during the Unit 2 transition from shutdown, through power ascension testing, to full power operations concurrent with Unit 1 operation.
