- a) Meet NRC Requirements (NRR) Activities that a) must be carried out to fulfill specific NRC requirements or b) have been committed to the NRC by the Company or c) are such that if not accomplished would result in an NRC non-compliance even though the specific activity is not required by the NRC.
- b) Meet Environmental Requirements (ERR) Activities that a) are specifically required by environmental regulatory agencies (State and Federal) or b) have been committed to environmental agencies by the Company or c) are such that if not accomplished would result in a regulatory non-compliance even though the specific activity is not required by an environmental regulatory agency.
