SUBJECT: NRC INSPECTION REPORT NO. 50-382/91-08

This refers to the inspection conducted by Messrs. R. A. Caldwell and A. B. Earnest of this office on February 27 through March 1, 1991. The inspection included a review of activities authorized by NRC Operating License NPF-38, for the Waterford Steam Electric Station, Unit 3 facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations of activities in progress.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements. No Notice of Violation (NOV) is being issued for one violation because it appears to be supplementary to the violation identified as 382/9101-02 in NRC Inspection Report 50-382/91-01. You should respond to the issue identified in paragraph 2.b of this report when responding to Violation 382/9101-02.

A second violation is not being cited because it meets the criteria identified in the NRC Enforcement Policy, Section V.A. This violation pertains to an inadequate procedure that was corrected by the licensee before the inspection concluded.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR Part 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material with the exception of the report cover page which is an inspection summary will not be placed in the Public Document Room.
