

Dear Mr. Schwencer:

In our reference 4) letter, we indicated that we expected to reply to the NRC request for information on Control Rod Drive System hydrodynamic loads by March 15, 1983. An analysis has been performed on a "one line, worst case basis" using test results from a set of scram valves from Limerick Unit No. 2. The analysis has recently been completed and a final report is being prepared by our consultant. We now expect to complete our review of this report and provide the response you have requested by April 29, 1983.
