SUBJECT: RECIPROCITY PROPOSAL FOR RADIOGRAPHY (REFERENCE: DOCKET
NO. 030-20037 AND FLORIDA LICENSE NO. 1219-1)

This refers to your letter of April 21, 1994, concerning radiography at Cape
Canaveral Air Force Station (CCAFS), under 10 CFR 150.20 reciprocal
recognition of the EG&G Florida, Inc., Agreement State License 1219-1.

Your proposal seems reasonable. The Florida State License holder (EG&G)
should submit a Report of Proposed Activities in Non-Agreement States (NRC
Form 241-Revised) to be effective for the balance of the calendar year 1994,
since there are fewer than 180 days remaining. The location (CCAFS) and
client (NASA) should be stated. A letter requesting the relief from
notification should accompany the Form 241.

You should contact Ms. Rita Messier of our License Fees and Debt Collection
Branch at (301) 415-6067 for the current fee requirements.

Upon approval of the reciprocity request, it would be appropriate under
License No. 09-21233-01 to submit a Certificate of Disposition of Materials
(NRC Form 314) stating that all the NRC licensed materials have been
transferred to the Florida State License, and request termination of the NRC
license. The request should be effective and filed prior to September 30,
1994.

A new application is required for each calendar year prior to conducting work
within NRC areas. We have enclosed copies of NRC Forms 241, and 314 for your
convenience.
