
Dear Mr. Russell:

At the request of Mr. James Joyner I am submitting this letter on behalf of Metreal, Inc. in response to the request for information by the NRC in a letter dated April 20, 1988 regarding license nos. 37-00030-02 and 37-00030-08. This information is being provided to you without waiving any rights or defenses which our clients may have in any subsequent proceedings which may be initiated by the NRC or any other state or federal agency.

Please be advised that Metreal, Inc. is not a licensee, nor does it conduct active operations at the Bloomsburg site. Metreal, Inc. owns approximately sixty (60) percent of the property at the Bloomsburg site which is subject to license no. 37-0030-02.




