

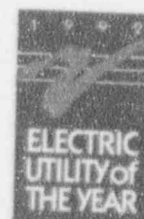

PERFORMANCE DATA

MRO SIX (6) MONTH REPORT

From July 1, 1993 through December 31, 1993, our records indicate two (2) confirmed positive tests in the random program for Duquesne Light Company employees. Both employees experienced denial of unescorted access, evaluation by the EAP Program and are presently participating in an intensive out-patient rehabilitation program.

One (1) employee, by job description and review of 10CFR, Part 26.73, proved reportable to the NRC Operation Center, by the Duquesne Light Company Security Department, on December 20, 1993 at 1715 hours. Report #26518 was made to Operations Duty Officer Thomas Andrews. The licensee was aware of the confirmed positive test result on December 20, 1993 at 1130 hours.
