This refers to the routine safety inspection conducted by Mr. Harry Kerch of this office on July 6 - 8, 1983, of activities authorized by NRC License No. DPR-44 to the discussions of our inspection held by Mr. Kerch with Mr. R. Fleischmann, III, at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of independent nondestructive examinations, selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.
