SUBJECT: REQUEST FOR ESTABLISHMENT OF A LOCAL PUBLIC
DOCUMENT ROOM NEAR NEWBURGH HEIGHTS, OHIO

This refers to our previous telephone conversations regarding distribution of documents contained in docket nos. 40-8724 and 40-7402 (Chemetron Corporation) to interested parties in the Cleveland, Ohio area. Due to increased Congressional and local public interest, as well as the possibility of a license hearing, we request that a local public document room (LPDR) be established near Newburgh Heights, Ohio so that official NRC documents can be available to interested parties.

At a January 1991 public meeting in Newburgh Heights, Ohio, NRC was requested to send all information contained in Chemetron docket files to the Mayor of Newburgh Heights, Ohio. Copies of documents from 1965 through March 1991 were sent to the Mayor on March 29, 1991, and comprised about two linear feet. A listing of these documents was filed with docket no. 40-8724 on April 5, 1991, which is provided in the enclosure to this memorandum.
