Dear Mr. Martin:

This letter responds to your request for information related to PP&L's review and disposition of security assessment concerns as identified in the referenced letter. Upon receipt of the letter PP&L conducted an internal investigation to determine the circumstances of the concerns.

A PP&L plant manager not affiliated with the security organization was assigned the responsibility to conduct the investigation. Personnel interviews conducted as part of the investigation identified two possible time periods that the events could have occurred. Therefore, to assure a thorough investigation both time periods were investigated. Based upon this investigation PP&L concluded that the events that led to the concerns identified were not a violation of regulatory requirements, did not degrade plant security, nor were they safety significant.

Attachment 1 to this letter provides the details of PP&L's review and evaluation of the concerns described and contains Safeguards Information. PP&L therefore, requests that Attachment 1 be protected against unauthorized disclosure in accordance with 10CFR73.21.

While PP&L did not find evidence of improper actions associated with these concerns, they are important to me personally. I intend to reinforce to the department, as appropriate, my standards concerning such issues.

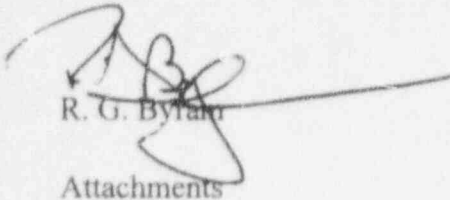
