COMMENTS

This confirms the telephone conversation on June 8, 1994, between you and Dick Lavins in which you withdrew your request for Notices of Violations (item 3 of your request) since you were informed that research on Inspection Reports issued in FY-89 and FY-90 indicates that an average of 12 percent of these reports are not recorded in the 766 System and that additional research on the 88 percent of the reports that are in the 766 System indicates that 37 percent of the reports have incorrect information about the severity level of the violations. You were also informed that the NRC believes that the error rates found for the FY-89-90 period will apply for the full 8 year period requested. You also agreed to accept a listing of Civil Penalties and Enforcement Orders (items 4 and 5 of your request) with enforcement specialist's initials deleted.

*Agency records subject to items 4 and 5 of your request that are identified on the enclosed Appendix A are enclosed. The NRC is continuing to search for records subject to your request. We will notify you upon completion of the search.
