Gentlemen:

I am responding to your letters of August 26, 1992, and August 30, 1993, requesting that Licenses 37-10305-05 and 37-10305-04 be combined since the Department administers both licenses. The Commission is considering your August 26, 1992, letter as a request to extend the filing deadline for termination in order to avoid the annual fee (Invoice No. AM02607-92) for License No. 37-10305-05.

Footnote 1 of 10 CFR 171.16 provides that the annual fee is waived where a license is terminated prior to October 1 of each fiscal year. The NRC has exempted from the FY 1992 annual fee those licensees, and holders of certificates, registrations, and approvals, who either filed for termination of their licenses or approvals or filed for possession only/storage only licenses prior to October 1, 1991, and were capable of permanently ceasing licensed activities entirely by September 30, 1991. An amendment request filed after October 1 of each fiscal year to cancel a license does not cancel the annual fee invoice.

The bases for your request are: (1) that you were not aware that you could consolidate your two existing licenses, 37-10305-04 and 37-10305-05, into one license which could include multiple locations; (2) you did not become aware that you could consolidate the licenses in time to meet the October 1, 1991, deadline.

Based on the information provided, the Commission grants an extension to the time to file for termination to August 26, 1992, for purposes of avoiding the FY 1992 annual fee for License 37-10305-05. Invoice AM02607-92 has therefore been cancelled.
