This letter refers to the announced safety inspection of your radiation protection program conducted by Mr. J. Nick of this office on October 4 - 7, 1994 of activities authorized by NRC License Nos. DPR-50 and DPR-73 at the Three Mile Island Nuclear Station in Middletown, Pennsylvania and to the discussions of our findings held by Mr. Nick with you and other members of your staff.

Areas examined in this inspection are important to public health and safety, and are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, you had in place effective programs for control of internal radiation exposure and assessment of internal exposure. No violations of regulatory requirements were observed, however, one safety concern was identified relative to the status of inoperable high radiation monitor alarm lights. No response to this letter is required.
