Dear Mr. Blair:

This is in reference to your application dated January 4, 2020, requesting to renew NRC License No. STC-133. All item numbers referenced correspond to Appendix B of NUREG-1556, Volume 7, Revision 1, "Program-Specific Guidance About Academic, Research and Development, and Other Licenses of Limited Scope," which was revised in February 2018, and can be located here: https://www.nrc.gov/docs/ML1806/ML18065A006.pdf. In order to continue our review, we need the following additional information:

- 1. Item 5 Radioactive Material Financial Assurance and Decommissioning Funding Plan documents must be updated every 3 years and at license renewals as required by 10 CFR 40.36(d)(2). Please state or provide the following with respect to "Financial Assurance and Recordkeeping for Decommissioning":
 - a. State the following: "Pursuant to 10 CFR 30.35(g), 10 CFR 40.36(f), and 10 CFR 70.25(g) and 10 CFR 70.51(b)(3), as appropriate, we will maintain records important to decommissioning and transfer these records to an NRC or Agreement State licensee before licensed activities are transferred or assigned, in accordance with 10 CFR 30.34(b), 10 CFR 40.46, and 10 CFR 70.36, as appropriate. Furthermore, pursuant to 10 CFR 30.51(f), 10 CFR 40.61(f), and 10 CFR 70.51(a)(3), as appropriate, prior to license termination, we will forward the records required by 10 CFR 30.35(g), 10 CFR 40.36(f), and 10 CFR 70.25(g), as appropriate, to the appropriate NRC Regional Office."
 - b. Please provide an update to the financial assurance cost basis provided in your submittal. The value in the Statement of Intent you provided in your current renewal application matches the cost estimate in the documents currently providing your financial assurance, namely the Certification of Financial Assurance and Statement of Intent dated July 7, 2015 (ML15209A650) and your Decommissioning Funding Plan dated October 27, 2015 (ML15309A353). However, you did not provide an updated basis for the Decommissioning Funding Plan cost estimate. The update should include any adjustments for changes in costs since the last time the estimate was provided, and any changes in the scope of decommissioning.

- 2. Item 9 Facilities and Equipment Please provide an updated facility diagram for the Defense Logistics Agency Strategic Materials Scotia Depot, including the following:
 - a. Include the area(s) assigned for the receipt, storage, security, preparation, measurement, use, and disposal of radioactive materials.
 - b. Submit a diagram showing the locations of shielding (if applicable), the proximity of radiation sources to unrestricted areas, and other items related to radiation safety.
 - c. Diagrams should be drawn to a specified scale, or dimensions should be indicated.
 - d. For facilities where it is anticipated that more than one room may be used, a generic room diagram may be submitted.

While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary. Keep in mind that all NRC licenses are considered to be
