Dear Ms. Bergin:

This is in reference to your letter dated January 20, 2020, requesting to amend NRC License No. 45-31299-01. In order to continue our review, we need the following additional information:

1. In accordance with 10 CFR 30.1 and 10 CFR 110.53, the NRC has jurisdiction only over persons in the United States and licensees must maintain an office in the United States where required records will be maintained. Therefore, we cannot change the address of this license to the manufacturing location in Canada. We do not have jurisdiction over any activities in Canada, only for the services authorized to be performed in the United States by your license. If there is another address in the United States that is preferred rather than that of the parent company address in Virginia, please provide that information.
2. Please provide information demonstrating that Eric McGinnis is qualified by training and experience to use, or supervise the use of, licensed materials during activities authorized by the license. Also provide information demonstrating that he is qualified to evaluate and designate other persons who will be authorized to use, or supervise the use of, licensed materials while performing activities authorized by this license.
