SUBJECT: ACKNOWLEDGEMENT LETTER REGARDING A RADIATION PROTECTION CONCERN AT CLINTON

Dear Mr. Cook:

Thank you for your letters dated December 28, 1994, and January 20, 1995, in response to our November 30, 1994, letter requesting information regarding a radiation protection concern at your Clinton Nuclear Power Plant.

In our letter, we requested that you review the concern and inform us of the results of your review including any identified problems or violations of your radiation protection program.

Your response indicated that the concern was investigated by an independent organization and no safety issues or violations of NRC regulations or licensee procedures were identified. Regarding the concern, the investigator concluded that you could not have positively declared that the individual in question had been sleeping in the Radwaste Operations Center (ROC) based on the available evidence. The investigator reached that conclusion after conducting interviews with the parties involved in the incident. A review of the corrective action data bases failed to identify any additional incidents of personnel sleeping on the job.

We found your investigation to be sufficient to support the actions taken by you following this incident. We have no additional questions regarding this matter. We request that you retain the supportive documentation of your review for a minimum of one year from the date of this letter.
