Gentlemen:

By letter dated January 14, 1994, and supplemented by letters dated August 1, 1994, October 25, 1994, December 13, 1994, and two letters dated December 22, 1994, PECO Energy Company (PECO Energy) submitted a Limerick Generating Station (LGS), Unit 1 and Unit 2 Technical Specification (TS) Change Request (i.e., 93-18-0) that proposed to increase the allowable leak rate for the main steam isolation valves (MSIVs) and to delete the MSIV Leakage Control System.

The proposed LGS Unit 1, and Unit 2, TS page 3/4 6-2 is being re-submitted and is revised to clarify how the proposed 100 scfh leakage criteria is applied during main steam isolation valve leakage testing. This clarification is consistent with the technical bases of our submittals, listed above, and the wording contained in NUREG 1433 "Standard Technical Specifications, General Electric Plants, BWR/4."

Attachment 1 to this letter contains the revised Unit 1 and Unit 2 TS page which supersede those previously submitted. This information is being submitted under affirmation, and the required affidavit is enclosed.






