was outside, I gave the bag  
of grass to my supervisor, I was  
told to go to the main office

at which I did the Stuart was  
there. I told what had  
happened, did you know that  
these people suspended me for  
30 days. I've seen coke dealt  
among the guards, I've seen  
guys give their bodies for their  
j's. I've found needles for  
heroin users in the blue rooms  
(outside bathrooms). I've seen  
funerals and cover ups so  
many times still they lie  
still they cover up these so  
called drug tests you pee into  
a bottle 7 weeks later you piss  
who's to know you are off so are  
people steal materials, tools computers  
paperwork, they say is lost, I've  
puzzled my dues sir that's why  
I'm fighting, I ask for compensation  
for pain and suffering back pay

work news corp, or state disability  
I'm seeing a psychologist and  
a physical doctor, I have  
nightmares, 6 different types of  
medications for teeth removed  
because of decay, thirty four  
months removed this is it for  
me they still lie and  
cover up, I have mine labors  
labors who help build this  
plant with their believed in  
it, labors who were told like  
myself you have a life time  
job, labors who were afraid  
to speak up some still are  
afraid, I'm not I know that  
god is stronger
