Please submit the close-out surveys and confirmation of transfer of all licensed material as a separate amendment to remove your facility at 1000 Tavern Road, Martinsburg, WV.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
