This will confirm my conversation with your office today regarding the Petitions for Review of ALAB-756 filed by the Joint Intervenors and Governor Deukmejian in this proceeding on January 9 and 11, 1984, respectively. Governor Deukmejian's Petition was filed on January 11, 1984 based on a two-day extension granted by you on January 9, 1984. Pursuant to 10 C.F.R. § 2.786(b)(3), answers would thus be required to be filed on January 24 and 26, 1984, respectively.
