Gentlemen:

This refers to the inspection conducted by Ronald A. Caldwell of this office during the period of April 18-20, 1983, for TRIGA Reactor Facility, of activities authorized by NRC Operating License R-113, and to the discussion of our findings with you and other members of your staff.

The inspection related to your program and activities designed to protect against industrial sabotage and to safeguard special nuclear material. The inspection was based on the applicable provisions of Title 10, Part 50 of the Code of Federal Regulations entitled "Licensing and Utilization Facilities," within Part 70 entitled Domestic Licensing of Special Nuclear Materials," and the specific requirements of NRC Operating License R-113. Areas examined during the inspection included Facility Organization and Operation; Measurement and Controls; Shipping and Receiving; Storage and Internal Controls; Inventory; and Records and Reports. These findings are documented in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of the inspection, no violations or deviations were identified.

In accordance with 10 CFR 2.790(d), the documentation of findings of your control and accounting procedures for safeguarding special nuclear materials and your facility's security procedures are exempt from disclosure. Therefore, the inspection report will not be placed in the Public Document Room and distribution will be limited.
