SUBJECT: EXAMINATION REPORT NO. 50-334/94-21(OL)

During the period of October 12-13, 1994, the NRC administered initial examinations to two senior reactor operator (instant) candidates from your company who were applying for licenses to operate the Beaver Valley Power Station, Unit 1. These examinations addressed areas important to public health and safety and were administered under Revision 7 to the Examiner Standards (NUREG-1021). At the conclusion of the examination, generic findings and observations that evolved as a result of the examination were discussed with Messrs. T. Noonan, L. Freeland, K. Ostrowski, and other members of your staff identified in the enclosed report.

Based on the results of the examinations, both of the senior reactor operator (SRO) candidates passed all portions of the examination and were subsequently granted licenses. The SRO candidates demonstrated, throughout the examination, the knowledge and ability necessary to safely carry out expected actions required of those who perform licensed activities.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and its enclosure will be placed in the NRC Public Document Room.
