DuBois of this office during the period of December 1-31, 1983, of activities authorized by NRC Operating License DPR-46, for Cooper Nuclear Station, and to the discussion of our findings with Mr. P. Thomason, and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included operational safety verifications, monthly surveillance and maintenance observations, plant trips - safety system challenges, followup of previously identified items, and station operations review committee. These findings are documented in the enclosed inspection report.
