12. DESCRIPTION OF AMENDMENT/MODIFICATION

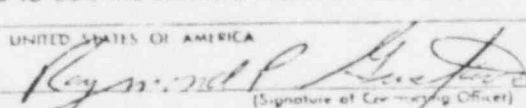
The purpose of this modification is to provide funds for CY84. In order to accomplish this, the following changes are hereby made:
