MEMORANDUM AND ORDER
(Order of Witnesses; Hearing Locations and Times)

After a non-transcribed telephonic prehearing conference that began yesterday at 2:30 pm, we determine that:¹

- the hearing will commence at 9 am, January 4 in Rockville, and will run through the morning of the 7th, if necessary.
- the order of witnesses during the first week of hearing is: Mr. Dahlberg, Mr. McDonald, Mr. McCoy, Mr. Hairston, Mr. Farley and Mr. Mosbaugh.
- the hearing will reconvene at 1 pm on the 9th of January in Atlanta, Georgia and will continue

until the morning of the 14th (the Atlanta Week), at a place to be announced.


- the Staff of the Nuclear Regulatory Commission is investigating a possible cite for the Atlanta Week and will report to the Board Chair soon about its success in this endeavor.
- Mr. Mosbaugh (Intervenor) will contact Mr. Frank Timmons and Mr. Michael Barker and each of witness for which it filed written direct testimony and will ascertain their availability during the Atlanta Week.
- Georgia Power Co., et al. (Georgia Power) will make reasonable efforts to contact each of the other Intervenor witnesses both to ascertain their availability for trial during the Atlanta week and to suggest an order of witnesses. It will provide this information to Intervenor by December 28.
- Intervenor will promptly inform Georgia Power if it requires a few changes in the order of testimony suggested on December 28.
- Cross-examination² should be focused and effective. In lieu of cross-examination plans, attorneys should be prepared to explain to the Board (at the bench and out of the hearing of the other

parties) what their examination plan is. Attorneys should know their cross-examination priorities. The Board may rule that cross-examination will be terminated at a certain time unless it is satisfied that the cross-examination continues to be purposeful and effective.

- Georgia Power's attorneys will consult with their client and promptly inform Intervenor whether it can dispense with the need for subpoenas for witnesses in order to expedite the hearing. (It should promptly inform the Board if it requires the issuance of subpoenas to any witnesses.)
- Intervenor's motion to issue subpoenas to Mr. Harris and Mr. Joiner shall be received by the Board and parties by December 23. Other requests for subpoenas must be filed by December 28.


