Gentlemen:

This refers to the special safeguards inspection conducted by Messrs. B. W. Stapleton and T. J. Madeda of the Region III staff on May 26, 1983, of activities at the Palisades Nuclear Plant authorized by NRC Operating License No. DPR-20. The results of this inspection were discussed on June 23, 1983 during an Enforcement Conference held at the NRC Region III office between you and members of your staff and Mr. A. B. Davis and other members of the Region III staff.

This inspection revealed that you did not adequately control access into the protected area of your facility. We are concerned that the access control system in place at the time of the incident did not provide the level of protection described in your security plan.

To emphasize the need to ensure that the approved security plan and implementing procedures are followed and to be cognizant of the potentially serious consequences of an unauthorized entry, we propose to impose a civil penalty for the violation set forth in the Notice of Violation and Proposed Imposition of Civil Penalty that is enclosed with this letter.

The violation in the enclosed Notice has been categorized at the appropriate severity level as described in the General Policy and Procedure for NRC Enforcement Actions (Appendix C to 10 CFR Part 2). The base value for a Severity Level III violation is \$40,000. However, in accordance with the NRC Enforcement Policy, we are reducing the amount of the civil penalty by 50 percent because of your prompt and extensive corrective action, including immediate disciplinary action and retraining for the individuals involved and increases in the licensee audit and surveillance program, contract agency performance objectives, and security incentive program. After consultation with the Director of the Office of Inspection and Enforcement, I have been authorized to issue the enclosed Notice of Violation and Proposed Imposition of Civil Penalty in the amount of Twenty Thousand Dollars.
