Gentlemen:

This refers to the inspection conducted by Messrs. E. H. Johnson, and J. P. Jaudon, of this office during the period June 27-July 1, 1983, of activities authorized by NRC Construction Permit CPPR-103 for the Waterford, Steam Electric Station, Unit 3, and to the discussion of our findings with Mr. W. Cavanaugh, and other members of your staff at the conclusion of the inspection.

The purpose of this inspection, as noted in the enclosed report, was to review the status of training of your facility staff. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to this violation, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

Further, it was found that certain of your activities appeared to deviate from a commitment contained in your FSAR. This item and reference to commitment are identified in the enclosed Notice of Deviation. You are requested to respond to this deviation in writing. Your response should be based on the specifics contained in the Notice of Deviation enclosed with this letter.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained wherein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
