13 performed, and the unit declared operable at 1030 hours, August 9, 1983. No

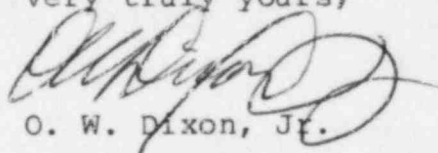
