Gentlemen:

This will acknowledge receipt of your response of December 19, 1994, to our Notice of Violation issued on November 17, 1994, concerning activities conducted at your Harris facility. We have evaluated your response and found that it meets the requirements of 10 CFR 2.201, except as noted below. We will examine the implementation of your corrective actions during future inspections.

Your response to Violation B does not address the extent of your review of other generic communications (i.e., deneric Letters, Bulletins, etc.). During the enforcement conference held on October 21, 1994, we understood that you intended to look at selected generic correspondence, and based on a telephone conversation on January 6, 1995, between Mr. Cantrell of my staff and Mr. McCarthy of your staff, we now understand that this has been initiated. Also, during a telephone conversation on January 6, 1995, between Mr. Cantrell of my staff and you, it was agreed that a revised response to Violation B will be provided to this office by January 20, 1995.

The response requested by this letter is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub. L. No. 96.511.
