Dear Mr. Perry:

This is in partial response to your letter dated July 1, 1983, in which you requested, pursuant to the Freedom of Information Act, all copies of notes, drafts, memorandums, and/or other records prepared by the Office of Investigations concerning the Zack Company and the investigation thereof.

In partial response to your request, copies of the documents listed on Appendix A are enclosed. Copies of these documents are also being placed in the NRC Public Document Room (NRC PDR) located at 1717 H Street, NW, Washington, DC where they will be available for public inspection and copying.

A portion of the resume of Albert T. Howard identified as an attachment to document 73 of Appendix A has been deleted to remove the home address and home telephone number of Mr. Howard. Also personal salary information of Mr. Howard and another individual have also been deleted from the attachment to document 73 of Appendix A. Disclosure of this information would constitute a clearly unwarranted invasion of personal privacy. The remaining nonexempt portion of this document has been released.

The withheld information is exempt from public disclosure pursuant to Exemption 6 of the Freedom of Information Act (5 U.S.C. 552(b)(6)) and 10 CFR 9.5(a)(6) of the Commission's regulations because its disclosure would constitute a clearly unwarranted invasion of personal privacy.

Pursuant to 10 CFR 9.15 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The person responsible for this denial is Mr. Ben B. Hayes, Director, Office of Investigations.

This denial may be appealed to the Commission within 30 days from the receipt of this letter. Any such appeal must be in writing, addressed to the Secretary of the Commission, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision."

You will be billed by Literature Research Company for the reproduction charges, plus tax and postage.

Additional documents which may be subject to your request are being reviewed to determine their releasability status, and we will communicate with you again when our processing activities are completed.
