Attached are two copies of the Exercise Report of the September 14, 1983, joint exercise of the offsite radiological emergency preparedness plans for the Dresden Nuclear Power Station. This exercise was small-scale for the State of Illinois and full-scale for Grundy, Kendall and Will Counties. The report, dated December 13, 1983, was prepared by Region V of the Federal Emergency Management Agency (FEMA).

Although there were deficiencies observed at the exercise, they did not detract from the overall demonstrated capability to protect the health and safety of the public. The State is preparing a schedule of corrective actions. As soon as they are received, we will send you two copies. However, since there were no identified impediments to protecting the public during the exercise, the "350" approval will remain in effect.

Dresden Nuclear Power Station Exercise Report

Attached is the Exercise Report for the Dresden Nuclear Power Station Exercise, conducted September 14, 1983.

The exercise demonstrated that the off-site preparedness continues to be adequate to provide reasonable assurance that appropriate measures can be taken to protect the health and safety of the public living in the vicinity of the nuclear power station in the event of a radiological emergency.

The exercise was evaluated under the Federal guidance of February, 1982. The State was unable to select exercise objectives from the list of 35 because it was not available at the time of submission. The new modular exercit was not implemented because it was received two days before the exercise. The report was written using the spirit and intent of the exercise guidance of August 5, 1983.

A schedule of corrections of deficiencies noted in the report has been requested from the State of Illinois by February 1, 1984.
