Dear Mr. Kraft:

This refers to the inspection conducted by C. Miller and others of this office, and R. Ganser from IDNS from November 11 through December 15, 1994. This inspection included a review of authorized activities for your Quad Cities Nuclear Power Station facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of a selective examination of procedures and representative records, interviews with personnel, and observation of activities in progress.

We acknowledge your continuing efforts to improve personnel performance and material condition. However, operational problems continued, and a significant failure in the use of administrative controls occurred shortly after the end of this inspection period, which resulted in unintentionally draining about 1800 gallons from the reactor coolant system of the shutdown unit. Based on this event and other operational errors that occurred during this inspection report period, the need for your continued attention to the conduct of operations was clearly demonstrated. We will review the cause and your corrective actions for the drain-down event during the current resident inspection effort.

During this inspection, certain of your activities appeared to be in violation of NRC requirements. The violation was categorized as Severity Level IV and is not being cited because the criteria specified in Section VII.B of the "General Statement of Policy and Procedures for NRC Enforcement Actions," (Enforcement Policy, 10 CFR 2, Appendix C) were satisfied.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosures will be placed in the NRC Public Document Room.
