This is to document the results of our review of the draft revisions to the New Mexico Radiation Protection Regulations, as submitted on September 12, 1994, and the revised draft dated December 8, 1994. The rules were reviewed in comparison to the equivalent NRC regulations in Title 10 of the Code of Federal Regulations, and the equivalent rules in the *Suggested State Regulations for the Control of Radiation (SSR)*.

In our review of the first draft, we identified a number of issues for comment as provided to you by facsimile and discussed in telephone conversations on November 29 and December 6, 1994. Our review of the second draft revealed that the previous issues have been appropriately addressed. Based on this, we offer a tentative finding that the revised draft regulations are compatible with the equivalent regulations of the Commission.

A final determination will be made after the New Mexico regulations are adopted as final rules and become effective. We request that a copy of the final regulations be provided to us when they are published.
