## Gentlemen:

Attached is a proposed amendment to the Arkansas Nuclear One - Units 1 and 2 Technical Specification, Sections 4.14 and 3/4.7.9, for your review and approval. This amendment will allow leak testing of sealed sources in radioactive systems to be performed when the specific plant system in which the seal is located is removed from service for maintenance or scheduled outages, as opposed to the present Technical Specification requirement of performing leak testing at intervals not to exceed six months.

In accordance with 10CFR50.92(c), we have determined the proposed amendment as having no Significant Hazards Consideration (SHC), and to satisfy the Sholly provisions, we are including the basis of our SHC determination as part of this amendment package. Also, a copy of this amendment package has been sent to Mr. E. Frank Wilson, Director, Division of Environmental Health Protection, Arkansas State Department of Health. The circumstances of this proposed amendment are neither exigent nor emergency; however, expeditious handling is requested.
