MEETING SUMMARY

Subject: Fire Protection Requirements

A management meeting was held in the NRC Region II office on January 12, 1984, to discuss the application of 10 CFR 50.48 and 10 CFR 50 Appendix R (Fire Protection) at the Farley Site. The following items were discussed in detail: protection requirements for equipment and components needed for cold shutdown; separation and/or fire barrier requirements for both major and minor components needed for safe shutdown; protection of steel supports for fire barriers and cable trays; protection requirements for areas involving "intervening combustibles" between safe shutdown components; detection and suppression requirements for fire areas involving safe shutdown equipment i.e., partial protection or total area protection requirements; and, repair requirements to equipment and components which would be damaged by an actual or a postulated fire. Based on the detail discussion, the licensee indicated that certain portions of the Farley Appendix R submittal would be reviewed to verify that the above items were adequately addressed and where applicable, sufficient exemptions would be submitted to the NRC.
