Gentlemen:

Attached is a copy of the Final Exercise Report prepared by the Federal Emergency Management Agency for the November 16, 1983 joint exercise of State and local radiological emergency preparedness plans for the Three Mile Island Unit 1 Nuclear Power Station. A copy of this report has been sent by FEMA to the Commonwealth of Pennsylvania requesting a schedule for corrective actions of offsite emergency preparedness deficiencies found during the exercise. FEMA has identified five Category A deficiencies, defined by FEMA as deficiencies that would cause a finding that offsite emergency preparedness was not adequate to provide reasonable assurance that appropriate protective measures can be taken to protect the health and safety of the public in the event of a radiological emergency. Category B deficiencies are also indicated for areas where corrections would enhance response capability. In connection with resolution of the deficiencies you should keep abreast of the activities taken by both the State and local authorities and provide assistance to them on an as needed basis.
