ORDER (Schedules for Proposed Findings of Fact and Conclusions of Law)

1. At the evidentiary hearing on September 23, 1983, we granted in part the Applicant's September 2, 1983 Motion to Reconsider Schedule for Submitting Findings of Fact on Remedial Soils Issues. We approved the following schedule for submitting proposed findings of fact and conclusions of law on the remedial soils issues:

2. We approved the following schedule for submitting proposed findings and conclusions on QA/management attitude issues (Tr. 21204-211). These proposed findings are to cover not only the managerial and SALP questions considered on September 21-23 but, in addition, the testimony concerning the alleged violation of the Board's April 30, 1982 Order to be heard during hearings scheduled to commence on October 31, 1983 (including testimony on Sinclair Contention 1a).

3. The parties are reminded that we expect proposed findings and conclusions on Sinclair Contention 14 (cooling pond effectiveness, including fogging and icing effects) to be filed on the same schedule as set forth for QA/management attitude issues (Tr. 20188-191). Proposed findings of fact and conclusions of law on other OL issues which have been heard (Sinclair Contentions 3, 4 and 13) should <u>not</u> be filed at this time. Nor is it contemplated that the scheduled proposed findings and conclusions on QA/management attitude issues will cover the
